#### **Terms & Conditions**

- 1. The Contractor should abide by the statutory provisions enacted in the labour laws for minimum wages and should fulfill all the statutory obligation under the ESI, Provident Fund rules etc. in respect of the persons deployed for the works. The Institute shall not provide/contribute towards the ESI/EPF etc.
- 2. The persons posted to work should attend the work between **09.00 a.m. to 17.00 p.m**. with ½ hour lunch break in the afternoon on all working days. In emergent situation, they should also work on holidays.
- 3. The persons entrusted with the work should carry out the work without causing any damages to the Institute property and disturbance to the staff members. In case of any damages caused, the same will be made good from the payment due to the Contractor.
- 4. The persons deployed for the work should be issued with **proper uniform** for easy identification at your cost. The service provider shall take all responsibility and obligation for providing security/ insurance of the person engaged by him by him for the purpose at CIFT. CIFT will not be responsible for any libel/suit/litigation or otherwise/obligation/commitment/liability to any party (ies) or person(s) whatsoever.
- 5.
