- III. Should have fabricated with minimum 6mm Thick IS 2042 & IS 2062 Grade Ms Plate
- IV. With required channels & Angles
- V. The incinerator system should have fully automatic & consist of the following:
 - 1. Automatic waste feeding system
 - 2. Combustion chamber (primary) made from IS 2042 grade mild steel materials
 - 3. Duly lined with High Alumina Fire bricks (better than IS-8 standard)
 - 4. Combustion chamber (secondary) made from IS 2042 grade mild steel materials
 - 5. duly lined with High Alumina Fire Bricks 9 better than IS -8 standard
 - 6. Fully automatic electric heating coils with all respect for primary & secondary

- 25. Minor civil works to fix/ install the machine shall be done by bidders. The required power will be terminated in a single location with a TPN in the proposed site. The required wiring panels/ MCCB/RCCB circuit breakers for installing the machine shall be done by the bidder.
- 26. The waterline/drainage will be provided at one single point in the proposed area
- 27. The plumbing from this point to the machine/back shall be done by the bidder.

GENERAL TERMS & CONDITIONS

- 1. Before quoting for the tender, it is requested to kindly go through the quotation Document thoroughly and abide by all the terms and conditions given.

6. Earnest Money deposit

The Contractor should furnish an **Earnest Money deposit** of **Rs.20,000**/- along with bid in the form of Account Payee Demand Draft from any of the Commercial banks in favour of "ICAR Unit CIFT, Cochin" payable at State Bank of India, Willingdon Island Cochin-682003, valid for 45 days beyond the validity of bid, is to be submitted to this office **on or before 19.01.2018**. Name of the Tender and Tender reference number has to be furnished behind the EMD DD/Bankers cheque. - 7. The quotation must be for the whole work and not in fragments.
- 8. The Institute will not supply any tools, equipment, materials. The contractor has to make their own arrangement.
- 9. Works are to be executed strictly as per the specifications mentioned in the tender document, failing which, payment will not be made. <u>Six months guarantee should be provided for the repairs</u> undertaken.
- 10. Mandatory tax will be deducted at source from the bill as per rules.
- 11. 1% of the billed amount towards water charges will be recovered, if water for the work is supplied by the Department.
- 12. Deductions for electrical charges either on actual basis or at the rate of 1% of the billed amount will be made if the electricity is supplied by the Department.
- 13. 5% the total amount quoted for one year will have to be deposited with the Institute by the contractor as Performance Security within 7th day of the award of the work. This amount shall be refundable without any interest after six months from the date of completion.
- 14. The agency has to abide by all rules and regulations pertaining to labour act. The contractor has to take all necessary steps for the welfare measures of labour employed by him at the site.
- 15. The agency will be fully responsible for providing medical facilities to their labourers in case of any accident, etc. Matters related to labour welfare/problems should be dealt by the contractor only. CIFT, Cochin shall not be responsible in such matters.
- 16. The tenders/bidders in their own interest are instructed to visit the site for understanding the site conditions, nature of work involved, etc
