

Enclosure 1: Detailed requirement and specification list of components,

The specification for fabrication of the rotary gantry arrangement for fish behaviour studies

1. A tank made of stainless steel 304 Grade of thickness 2.5 mm or FRP with appropriate thickness with, 2.3 meter dia and 1-meter height to contain sea water. (The tank should withstand corrosion against seawater)

- 2. A rotating arm of 2 meter dia with a fish holding on one side and a counterbalance on the other.
- 3. One servo motor and gear box combination required for precise motion of the arm/gantry
- 4. Mechanical structure required for housing the motor and the arm
- 5. LUX meter to measure the light intensity
- 6. One operator station with a software program to control the various modes of operation of the rotating arm.
- 7. Miscellaneous accessories like cables and conduits
- 8. Splash proof HD camera for recording



The layout of the system

The overall Layout of the system is as shown in the image above. The system would consist of a Tank (Stainless steel or FRP with appropriate thickness) mounted on the ground. A structural support would be placed over the tank to mount the motor and the gear box combination that would help in the rotation of the arm. A fish trap should be provided at one end of the arm and a counterbalance on the other side.

The fishes under study are placed in the trap, and the arm is rotated at a preselected velocity, thus simulating the movement of a trawler/fishing boat.

Various profiles and speeds of motion should be achieved through a software for this purpose. The same should be customized as per the requirements of CIFT.

Provisions should be made such that images can be captured through the software with appropriate time stamping and any other data like water temperature, speed of motion, type of mesh, etc, on the image for easier post processing. The camera should be splash proof with HD recording. A lux meter for measuring the intensity of light is also required.
