Terms and Conditions:-

- 1. Divers should have relevant national/international certificate in sea diving.
- 2. The minimum diving depth during experiments will be 30 meters in sea conditions.
- 3. The divers should have their own equipment needed for diving and the rates quoted will be **per person per day basis**, which will be inclusive of the equipment and consumables used for diving.
- 4. The rate for underwater photography and videography should be included with the quoted rate.
- 5. Two persons are required at the same time on the same day during the experiments involving diving operations.
- 6. The services of the divers should be provided as on demand (two persons on the same day and same time).
- 7. Services are required for a minimum period of one year from the date of signing the contract.
- 8. Party cannot claim any sort of insurance from CIFT for the risk involved during the diving operations.
- 9. The insurance coverage for the diving equipment and life of the diver should be taken care by the party. CIFT will not be responsible for the same.

- 10. The Agency's terms and conditions, if any, must be furnished along with the quotation letter.
- 11. GST/IT etc. are applicable as per rule.
- 12. Payment will be made only by e-payment on satisfactory completion of the work and submission of pre-receipted bill.
