The following corrections are incorporated in the **TENDER FOR TUNA LONG LINER CUM TRAWLER (MULTIPURPOSE, GREEN, DEEP SEA, RESEARCH VESSEL) FOR ICAR-CIFT, KOCHI: -**

1. Vessel will be constructed as per IRS requirements. IRS classification certificate need not be insisted.
2. Regarding sea trials, it is clarified that all sea trials will be carried out at 85% of MCR
3. Clause 1.8 of the technical specification in tender document: It is clarified that the GA, Preliminary stability calculations and Structural design are to be approved by ICAR-CIFT before commencement of construction
4. Clause 2.0.4 of the technical specification in tender document: It is clarified that SA2.5 surface preparation by blasting to be done before painting.
5. Clause 3.0.3 of the technical specification in tender document: Since list of documents to be submitted is specified in tender document, the sentence 'Design of propeller and Kort nozzle will be provided by CIFT' is removed
6. Clause 3.0.6 of the technical specification in tender document: It is clarified that Trawl Winch - Warp length -700m is on each drum
7. The Bid submission end date has been extended to 11.10.2025 and Technical bid opening date to 13.10.2025. The Bid Security submission last date is 10.10.2025
8. Clause 8.I.(i) of General Terms and Conditions is modified as 'Detailed General Arrangement Plan including accommodation and laboratory layout'. Serial Nos. (b) to (g) are not needed at the time of submission of tender.
