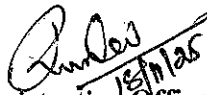

3. The post is reserved exclusively for SC Candidates

5. Candidate should possess 1st class or 60% marks or equivalent overall GPA.

Candidates are required to submit detailed bio-data (in the enclosed format) affixing a recent passport size photograph along with attested copies of all the Certificates in support of their claims regarding age, educational qualifications, experience, Scheduled Caste. **The original certificates shall be produced for verification before the interview.**
