
Emoluments	:	Rs.37,000/- + HRA per month for 1 st & 2 nd year and Rs.42,000/- per month for 3 rd year.
Essential Qualification	:	Master degree or MFSc in Fish Processing Technology / Industrial Fisheries Technology or relevant subject / Fisheries Business Management / Fisheries Economics / Post-graduation or Master degree in Business Management / MBA / Food Technology / Food Science / Industrial fisheries technology from a recognized university / institution having 1 st division or 60% marks or equivalent overall grade point average.
Desirable Qualification	:	Candidate with working experience in fisheries / fish processing/ food processing / business activities for a minimum of 2 years. Candidates with relevant scientific research publication in the above area are desirable. NET qualification is desirable for candidates with post-graduation in basic sciences with 3 years Bachelor's degree and 2 years of Master's degree.
