Desirable Skills	:	Experience in operating LC-MS/MS, GC-MS/MS. Experience in pesticide, and antibiotic residue testing, conducting wet lab experiments, Monitoring of fish health during infection studies, Collection of farm sediments, water and animals, and residue degradation studies. Coordination with laboratory staff for various project related activities.
Age	:	Candidates should be above 21 years and maximum of 45 years as on date of interview. Age relaxation as per rules.
