## **ICAR-CIFT**

ICAR-CIFT plays a vital role in the development and implementation of quality and food safety in the fish processing industry and in developing standards for fish and fishery products for domestic & export markets. As a Referral Laboratory of FSSAI, the institute carries out regular analysis of domestic and imported fish samples on safety aspects.

### **About the training**

This advanced training course is offered for graduate and post-graduate students in the discipline of Fisheries Science/Food Science/Food Technology/Industrial Fisheries/any other equivalent or relevant food science disciplines. The objective of this course is to update the knowledge about seafood quality and safety aspects. This course will be beneficial for graduates seeking careers in both research and the processing industry.

### **Topics covered**

- Quality control aspects in fish and fishery products
- Sensory analysis of fish and shellfish
- Microbial and chemical quality indices in fish
- Instrumental techniques for analysis of seafood quality and safety

### **Duration**

The training will be of 4 days duration and is scheduled to be organized during 07-10 October 2024.

### **Eligibility**

This is a special capacity-building programme for the students belonging to the Scheduled Tribe category. Graduate and post-graduate students in Fisheries Science/Food Science/Food Technology/Industrial Fisheries/any other equivalent or relevant food science disciplines are eligible to apply. A total of 20 candidates shall be selected for the course. A screening committee shall make the selection of the candidates as per the guidelines of ICAR. The selected candidates shall be intimated regarding their selection for training on 03 October 2024.

### **Procedure of participation**

Eligible candidates may prepare as per the format given in the brochure. The participants may send the application form duly filled in and approved by the competent authority of the organization to the Course Director at the address given in the brochure by email (qamdiv@gmail.com).

### **Travel, Food & Accomodation**

The candidates selected for participation in the training shall be reimbursed travel expenses (to and fro) as per their entitlement restricted up to sleeper class rail fare by the shortest route subject to submission of documentary evidence in terms of original tickets. Participants will be provided with food & accomodation as per ICAR norms at the expense of CIFT.
